

# Data Protection Notice

The following data protection declaration applies to the entire offer of CAHM Europe SRL. Personal data are only recorded on this website to the scope technically necessary. Under no circumstances are the recorded data sold or forwarded to third parties for other reasons.

The following declaration gives you an overview of how we guarantee this protection and of the kind of data recorded and the purposes for which they are recorded.

## Data processing on this Internet site

CAHM Europe SRL automatically records and stores information which your browser transmits to us in the server log files. These are:

- browser type/version
- operating system used
- referrer URL (the site you have come from)
- host name of the accessing computer (IP address)
- time of the server inquiry

These data cannot be assigned to certain individuals for CAHM Europe SRL. A combination of these data with other sources of data is not carried out.

## Safety of your personal data

CAHM Europe SRL treats all the data collected confidentially and protects your personal data against unauthorized access, use or publication. These data can be seen by third parties without any reference to CAHM Europe SRL.

## Forwarding of your data
